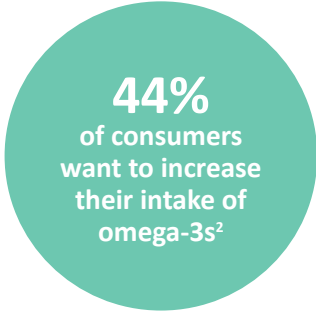

Studies show that DHA has several potential benefits for cardiovascular function:³

- Improves blood pressure
- Improves plasma lipids
- Improves vascular function
- Reduces inflammatory markers

COGNITIVE HEALTH

DHA is integral to cell membranes of the brain and central nervous system, and is important for cognitive development. Studies show that DHA:

- Supplementation with EPA is associated with increased memory and/or reduced memory loss⁴
- Contributes to maintenance of normal brain function⁵
- Maternal intake contributes to normal brain development of fetus and breastfed infants⁵

Concentrated in the retina, DHA is important to the development of normal eye function. Studies show:⁶

- Dietary deficiencies of DHA are associated with impaired vision and increased risk of macular degeneration

- Maternal DHA intake contributes to normal development of the eyes of fetus and breastfed infants

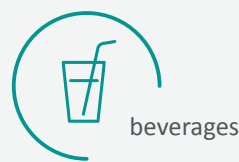
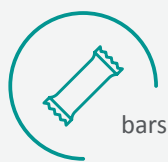
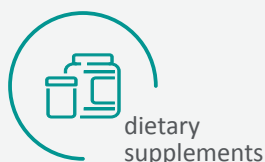
